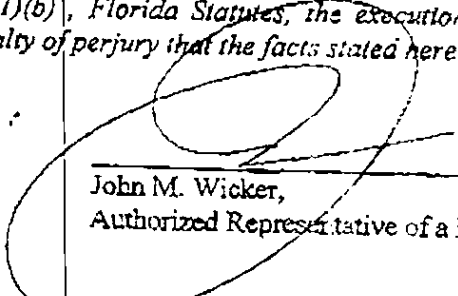
ARTICLE 9

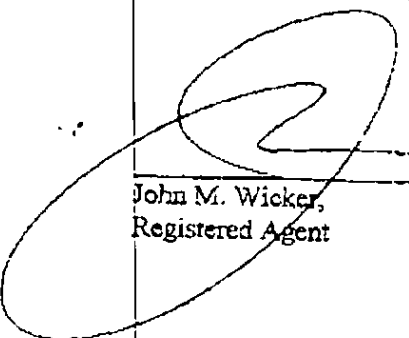
