The following articles of merger are submitted in accordance with the Florida Business Corporation Act, pursuant to Section 605.1025, Florida Statutes:

FIRST: The name and jurisdiction of the surviving entity is EVIDERA, INC., a Delaware corporation.

SECOND: The name and jurisdiction of the merging entity is FIELDACCESS, LLC, a Florida limited liability company.

SECOND: The merger was approved by the domestic merging entity in accordance with section 605.1023, Florida Statutes, and by the organic law governing the surviving entity.

THIRD: The name of the surviving entity is EVIDERA, INC., a Delaware corporation.
