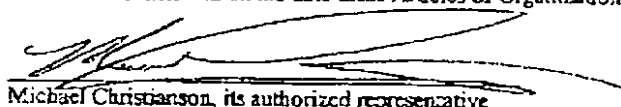
**ARTICLE V. INITIAL REGISTERED OFFICE AND AGENT**

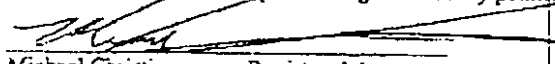
**ARTICLE VI. COMMENCEMENT OF EXISTENCE**
