The name and address of the registered agent and office of the Company shall be **Nancy Cabral**, 4501 3rd Avenue S.W., Naples, Florida 34119.



The Company's day to day business will be managed by one of its Members and is therefore a member-managed company. The initial member manager is **Nancy Cabral**.


