

AGREEMENT AND PLAN OF MERGER OF [TRACTIONVILLE, LLC], A FLORIDA LIMITED LIABILITY COMPANY WITH AND INTO [SYSTEM & SOUL FRAMEWORK, LLC], A GEORGIA LIMITED LIABILITY COMPANY

THIS AGREEMENT AND PLAN OF MERGER ("Plan of Merger") is entered into as of December 31, 2021, by and between [SYSTEM & SOUL FRAMEWORK, LLC], a Georgia limited liability company ("Surviving Entity"), and [TRACTIONVILLE, LLC], a Florida limited liability company ("Merged Entity").

WHEREAS, Surviving Entity and Merged Entity desire that Merged Entity should be merged with and into Surviving Entity, with Surviving Entity thereafter to be possessed of all the estate, property, rights, privileges, and franchises of Merged Entity;

THEREFORE, Merged Entity and Surviving Entity hereby agree as follows:

- As soon as practicable after the adoption of this Plan of Merger, appropriate documents (the "Merger Filings") shall be filed in the offices of the Secretary of States of Florida and Georgia to effectuate the merger transaction contemplated hereby (the "Merger"). The term "Effective Time" as used herein shall mean the date on which the Merger Filings are accepted for filing with the Secretary of State of Florida.
- 2. At the Effective Time, Merged Entity shall be merged with and into Surviving Entity, and the separate existence of Merged Entity shall cease (such transaction is herein referred to as the "Merger"). Surviving Entity shall be the surviving entity, and it shall continue to be governed by the laws of the State of Florida.
- 3. The ownership of the equity interests of the Surviving Entity following the Merger shall be as set forth Operating Agreement of Surviving Entity.
- 4. The Operating Agreement of Surviving Entity in effect immediately prior to the Effective Time shall continue as the Operating Agreement of the Surviving Entity.
- 5. The managers and officers of Surviving Entity holding office immediately prior to the Effective Time shall be the managers of the Surviving Entity.
- 6. This Plan of Merger may be amended for any reason at any time prior to the filing of the Merger Filings with the Secretary of State of Florida by the managers of Merged Entity and Surviving Entity.

- 7. The managers of Merged Entity and Surviving Entity shall execute the Merger Filings and file them with the Secretary of State of Florida.
- 8. The managers of Merged Entity and Surviving Entity shall do all acts and things whatsoever, whether within or without the State of Florida, that may be in any way necessary or proper to effect the Merger.
