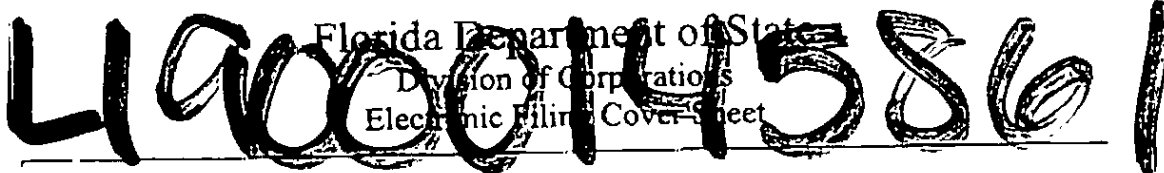

The undersigned, desiring to form a limited liability company under and pursuant to § 605.0201, Florida Statutes does hereby certify as follows:

ARTICLE I – NAME:

The name of the Limited Liability Company shall be:

ARTICLE II – TERM:

JUSTWELL HEALTH, LLC shall exist in perpetuity.

ARTICLE III – PRINCIPAL ADDRESS:
