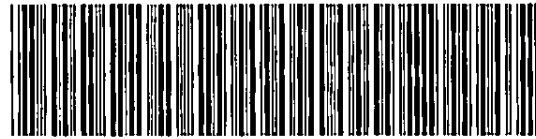



The limited liability company shall not be liable for the personal debts of the initial members or of any additional member(s) subsequently added from time to time as provided for under Article VII.


