**ARTICLE IV**

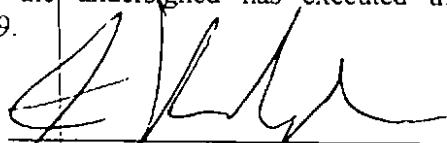
