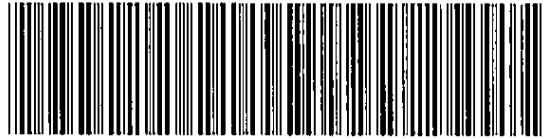

ARTICLES OF ORGANIZATION OF VUCA17, LLC

The undersigned, acting as the organizing Member of this limited liability company pursuant to Chapter 605 of the Florida Statutes, hereby forms a limited liability company under the laws of the State of Florida and adopts the following Articles of Organization for said limited liability company:
