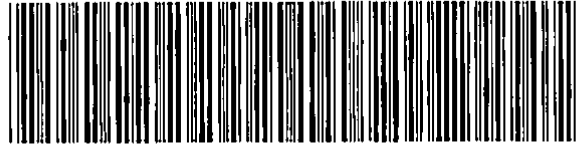

FIRST: This Amended Restated Articles of Organization amends and restates the Articles of Organization of PATRIOT GUTTER SERVICE, LLC.
