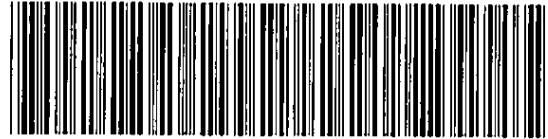

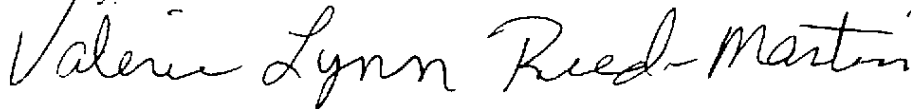

ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 605 hereby makes, acknowledge, and file the following Articles of Organization.

ARTICLE I – NAME

The name of the limited liability company shall be GENDER UNLIMITED GLOBAL

ARTICLE II – ADDRESS

ARTICLE III – DURATION

members of the company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

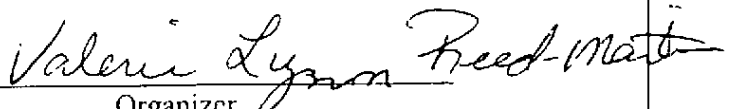
ARTICLE VIII – TERMINATION OF EXISTENCE

ARTICLE XI – MANAGEMENT

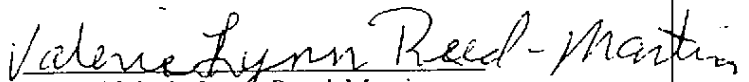
