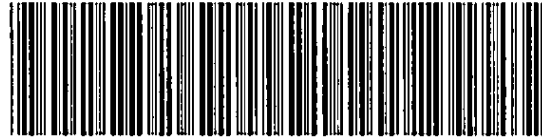

**ARTICLES OF ORGANIZATION  
OF  
ITAL BOWLS MANAGEMENT LLC**

The undersigned, for the purpose of forming a Limited Liability Company under the "Florida Revised Limited Liability Company Act," F.S. Chapter 605 (the "Act"), does hereby adopt the following Articles of Organization:

**ARTICLE I**

The name of the limited liability company is **Ital Bowls Management LLC** (the "Company").

**ARTICLE II**

The principal place of business and mailing address of the Company shall be c/o MAI Law Firm, 660 NE Ocean Blvd., Suite 2 SE, Stuart, FL 34996.

**ARTICLE III**

The Company may transact any and all lawful business for which limited liability companies may be organized under the Florida Revised Limited Liability Company Act.

**ARTICLE IV**

In accordance with Section 605.0108(3) of the Act, the term of existence of the Company shall commence upon filing these articles of organization with the Florida Department of State. The Company's existence shall be perpetual unless the Company is earlier dissolved.

**ARTICLE V**

**ARTICLE VI**

The Company shall be a manager managed company. The initial Manager of the Company is Zachary C. Bucolo. The Operating Agreement may contain provision for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

**ARTICLE VII**

These Articles of Organization may be amended by consent of the Members or as may otherwise be provided by law.

## ARTICLE VIII

The Company shall indemnify any person who was or is a party to any proceeding or faces any claim (other than an action by, or on behalf of, Company) by reason of the fact that he or she is or was a director, officer, committee member, employee, lawyer or agent (each, an "Indemnitee") of the Company, against liability incurred in connection with such proceeding or claim, including attorneys' fees for all pre-litigation, litigation and any appeal thereof to the fullest extent permitted under the laws of Florida.
