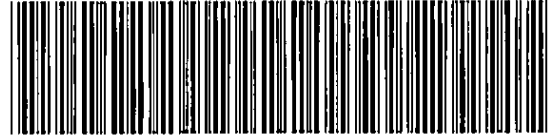

# ARTICLES OF ORGANIZATION

### ARTICLE I - NAME

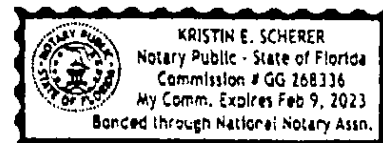


