# ARTICLES OF ORGANIZATION

#### OF

# TWO C'S PROPERTIES, LLC

These Articles of Organization are made for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (Ch. 605, Florida Statutes, 2017).

# ARTICLE I

#### NAME

The name of this limited liability company is TWO C'S PROPERTIES, LLC (the "Company").

### ARTICLE II

# DURATION

The Company shall exist for indefinite duration from the date of filing these Articles of Organization with the Department of State until the occurrence of any of any of the events specified in Section 605.0701, Florida Statutes (2017), unless continued by the unanimous consent of all of the remaining members.

# ARTICLE III

# MAILING ADDRESS AND STREET ADDRESS

The mailing address and the street address of the principal office of the Company is 5916 6th Street, Tampa, FL 33611.

#### ARTICLE IV

# REGISTERED AGENT AND OFFICE

The name of the initial registered agent of the Company is GARY A. GIBBONS, and the street address of the initial registered office of the Company is 3321 Henderson Blvd., Tampa, Florida 33609.

#### ARTICLE V

#### ADDITIONAL MEMBERS

Additional members may be admitted and membership interests may be transferred, but only if all of the current members agree to the admission of the additional members and to the terms of admission and transfer, in accordance with the provisions of the Operating Agreement.

#### ARTICLE VI

#### TERMINATION OF MEMBERSHIP

Upon the death, legal disability, retirement, resignation, expulsion, bankruptcy or dissolution of a member or upon the occurrence of any other event which terminates the continued membership of a member in the Company, the Company shall not be dissolved unless the remaining members, by written agreement, consent to dissolve the Company.

#### ARTICLE VII

#### MANAGEMENT OF THE COMPANY

The Company shall be managed by the Manager(s) in accordance with the Company's Operating Agreement, and is therefore a manager-managed company. The Company shall initially be managed by the following managers until the first meeting of the members or until successors are elected and qualified: DANA M. COBERLY, whose mailing address is 5916 6th Street, Tampa, FL 33611.

### ARTICLE VIII

# OPERATING AGREEMENT

The members shall have the power to adopt, alter, amend or repeal an Operating Agreement for the Company containing provisions for the regulation and management of the affairs of the Company.

# ARTICLE IX

# DATE OF EXISTENCE OF THE COMPANY

The existence of the Company shall commence on the date of filing of these Articles of Organization with the Department of State.

# ARTICLE X

# **POWERS**

The Company shall be authorized to engage in any lawful business and shall have all powers as are provided in Section 605.0109, Florida Statutes (2017), and such other powers as are set forth in the Operating Agreement of the Company.
