**ARTICLES OF ORGANIZATION

The Company shall be managed by the Manager(s) in accordance with the Company's Operating Agreement, and is therefore a manager-managed company. The Company shall initially be managed by the following managers until the first meeting of the members or until successors are elected and qualified: DANA M. DATE OF EXISTENCE OF THE COMPANY


The existence of the Company shall commence on the date of filing of these Articles of Organization with the Department of State.
