**ARTICLES OF ORGANIZATION

Andrews, Jr., a natural person competent to contract and an authorized representative of Gulf Front Lifestyles, LLC, hereby presents these Articles of Organization as the Articles of Organization of Gulf Front Lifestyles, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

**ARTICLE I - NAME**

The name of the limited liability company is Gulf Front Lifestyles, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

**ARTICLE II - PRINCIPAL OFFICE ADDRESS**


**ARTICLE VI - MANAGEMENT**


