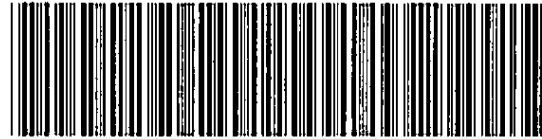

Pursuant to Section 605.0201 of the Florida Revised Limited Liability Company Act, as amended from time to time (the "Act"), the following are adopted as the Articles of Organization of the professional limited liability company organized hereby:

**ARTICLE I
NAME**
