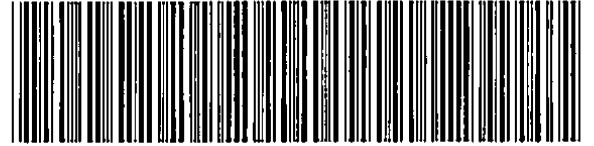

Management



Authority & Purpose

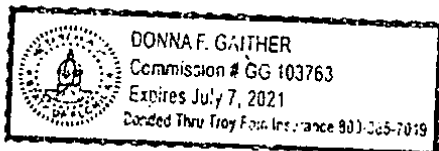


