Article I
Name

The undersigned, as the sole member of **ROUGH RIDER CONSTRUCTION, LLC**, hereby executes and adopts the following Amended and Restated Articles of Organization of the limited liability company ("Company") **ROUGH RIDER CONSTRUCTION, LLC**.

Article II
Address

Article III
Duration

The period of duration for the Company is perpetual, beginning on the date these Articles of Organization are filed by the Florida Department of State.

Purpose and Powers


Admission of New Members

Members of the Company have the right to admit new members.
