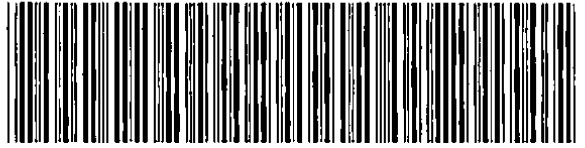



ARTICLE IV - MANAGEMENT.


