

ARTICLES OF ORGANIZATION OF PCB SOUTH, LLC

The undersigned, Robert A. McIntosh, a natural person competent to contract and an authorized representative of PCB South, LLC, hereby presents these Articles of Organization as the Articles of Organization of PCB South, LLC, a limited liability company formed under the provisions of Chapter 605, Florida Statutes.

ARTICLE I - NAME

The name of the limited liability company is PCB South, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE V - REGISTERED OFFICE AND AGENT


