The street address and mailing address of the principal office of the Company is 4131 S.W. 47th Avenue, Suite 1408, Davie, FL 33314.

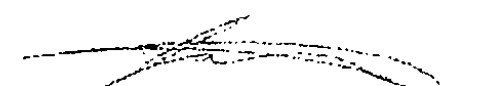
**ARTICLE III

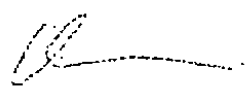
