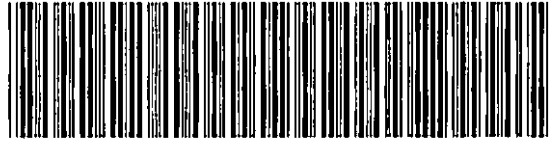


1. The name of the limited liability company is TB HOMES LAND LVII, LLC.
