### **ARTICLES OF ORGANIZATION**

<u>OF</u>

### GULF COAST PSYCHIATRY, PLLC

The undersigned, for the purpose of forming a professional limited liability company under the Florida Liability Company Act, F.S. Chapter 605, hereby make, acknowledge, and file the following Articles of Organization:

#### **ARTICLE I**

#### **NAME**

The name of this Professional Limited Liability Company shall be GULF COAST PSYCHIATRY, PLLC.

#### **ARTICLE II**

#### **ADDRESS**

#### <u>ARTICLE III</u>

#### PERIOD OF DURATION

The Company shall commence its existence on the date these Articles of Organization are filed by the Florida Department of State. The Company's existence shall be perpetual, unless the Company is dissolved earlier as provided in the Articles of Organization or adopted by members.

#### ARTICLE IV

#### REGISTERED OFFICE AND AGENT

The initial street address in Florida of the initial registered office of the Company is  $93\overline{0}$  CENTRAL AVE, UNIT 503, ST. PETERSBURG, FL 33705 and the name of the initial registered agent at such address is JASON PATEL.

#### ARTICLE V

#### PROFIT & LOSSES

- 1) SHARING OF PROFITS: The members shall be entitled to the net profits arising from the operation of professional limited liability business that remains after the payment of the expenses of operating the business of the limited liability company. Each member shall be entitled to their distributive share of the profits according to their percent of interest in the company.

A member may transfer his or her interest in the Company as set forth in the Regulations of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

#### **ARTICLE VIII**

#### MEMBER'S RIGHT TO CONTINUE BUSINESS


