AMENDED AND RESTATED ARTICLES OF ORGANIZATION OF JB INVESTMENT PROPERTIES, LLC

Pursuant to Section 605.0202 of the Florida Revised Limited Liability Company Act, the Articles of Organization of JB Investment Properties, LLC, originally filed on June 27, 2019, are amended and restated in their entirety to read as follows:

ARTICLE I - NAME

The name of the limited liability company is JBD Investment Properties, LLC (the "Company").

ARTICLE II - ADDRESS
