### PLAN OF CONVERSION

This Plan of Conversion is hereby adopted this 4<sup>th</sup> day of November, 2020, by Dean Abraham Martin, (the "Sole Member"), the sole member of MARTIN & FAMILY DELIVERY LLC, a Florida limited liability company (the "Company").

### RECITALS

- A. The Company was formed under the name MARTIN & FAMILY DELIVERY LLC, on June 27, 2019. Dean Abraham Martin is the sole member of the Company.
- B. A conversion of a Florida limited liability company into a Wisconsin limited liability company may be made under Fla. Stat. § 605.1041 and Wis. Stat. § 183.1207.
- C. The undersigned Member of the Company hereby agrees to convert the Company to a Wisconsin limited liability company to be known as MARTIN & FAMILY DELIVERY LLC, and to perform such acts and execute such documents as may be necessary and/or convenient to affect the Conversion.
