

ARTICLES OF ORGANIZATION of AUGMINTELLIGENT, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be AugmIntelligent, LLC (the "Company"). The mailing and street address of the principal office of the Company in Florida shall be 6210 St. Andrews Court, Ponte Vedra Beach, Florida 32082.

ARTICLE II

PURPOSES AND POWERS
