ARTICLES OF ORGANIZATION
of

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be ANS Leaf, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 3733 University Boulevard, Unit 208, Jacksonville, Florida 32217.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VI**MANAGER**
