ARTICLES OF ORGANIZATION
of
CR LEAF, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be CR Leaf, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 3733 University Boulevard, Unit 208, Jacksonville, Florida 32217.

ARTICLE II

PURPOSES AND POWERS

The general purpose for which this Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. ARTICLE VI**MANAGER**

The Company shall be managed by one or more managers and is, therefore, a manager-managed limited liability company. 
