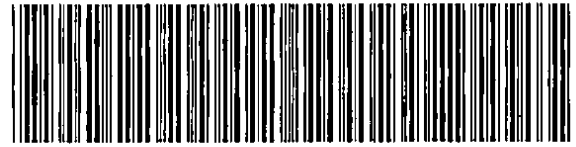





Management


