## ARTICLES OF ORGANIZATION OF HOFFMANN KEDS, LLC,

a Florida Limited Liability Company

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 695, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

## ARTICLE I NAME

The name of the limited liability company is HOFFMANN KEDS, LLC, a Florida limited liability company (the "Company").
