Pursuant to the provisions of Chapter 605 of the Florida Statutes, the undersigned hereby declares the following amendment (the "Amendment") was adopted to the Articles of Organization of AMBROSIA RESTAURANT, LLC, a Florida limited liability company ("the Company") originally filed with the Secretary of State, State of Florida on July 19, 2019, and assigned Florida document number L19000177523:
