

ARTICLES OF ORGANIZATION OF Laureate, LLC

The undersigned certify that we have associated ourselves together for the purpose of becoming a limited liability company under the Laws of the State of Florida, Chapter 605, Florida Limited Liability Company Act, providing for the information, rights, privileges, and immunities of limited liability companies for profit. ARTICLE V MEMBERSHIP RESTRICTIONS

Members shall have the right to admit new members by unanimous consent. Contributions required of new members shall be determined as of the time of admission to the limited liability company.
