**ARTICLES OF ORGANIZATION
OF

The undersigned, Elizabeth Paige Rawson, a natural person competent to contract and an authorized representative of Coastal Site and Erosion, LLC, hereby presents these Articles of Organization as the Articles of Organization of Coastal Site and Erosion, LLC, a limited liability company formed under the provisions of Chapter 605, *Florida Statutes*.

ARTICLE I - NAME

The name of the limited liability company is Coastal Site and Erosion, LLC. This limited liability company is referred to in these Articles of Organization as the "Company."

ARTICLE II - PRINCIPAL OFFICE ADDRESS

The initial mailing address and initial principal address of the Company is 1360 E. Scott Street, Pensacola, FL 32503. The Company's mailing address and principal office may hereafter be at such other place or places as its members from time to time may determine.

ARTICLE III - PURPOSE AND POWERS

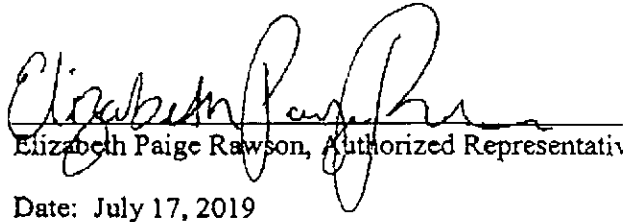
ARTICLE VI - MANAGEMENT

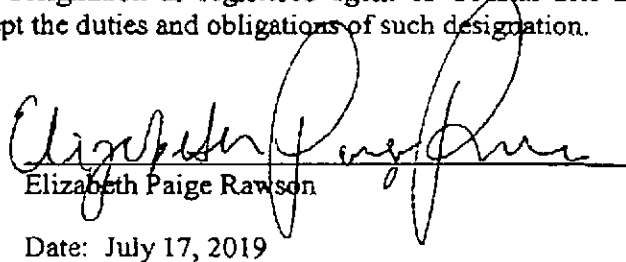
