**ARTICLES OF ORGANIZATION

The undersigned subscriber to these Articles of Organization, a natural person competent to contract, does hereby form a limited liability company under the laws of the State of Florida.

**ARTICLE I
Name**

The name of the limited liability company shall be Pinellas Holdings 19-BR LLC.

**ARTICLE II
Address and Place of Business**

Period of Duration**

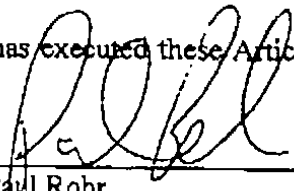
ARTICLE VIII

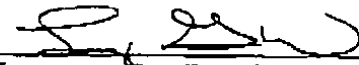
