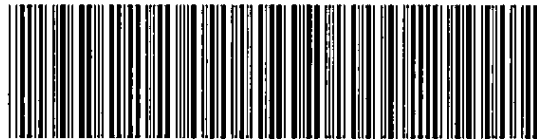




ARTICLES OF DOMESTICATION

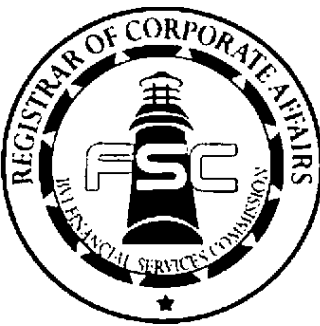


