DURATION**

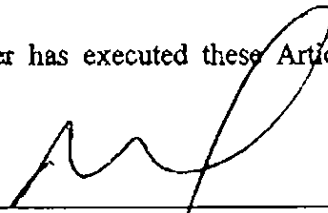

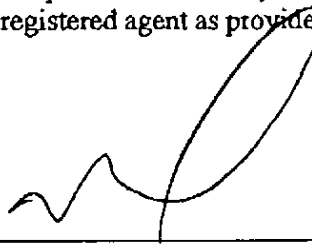
