The name of the Limited Liability Company is "Hyde 1212, LLC" (the "Company").

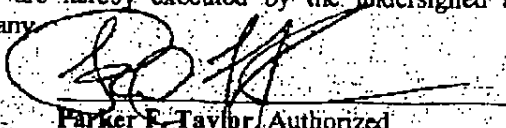
