ARTICLES OF ORGANIZATION OF PORTAL REALTY, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act (the "Act") of the State of Florida pursuant to Chapter 605 of the Florida Statutes hereby makes, acknowledges, and files the following Articles of Organization providing for the formation, rights, privileges, and immunities of limited liability companies for profit.

ARTICLE I NAME

The name of the limited liability company shall be PORTAL REALTY, LLC
(the "Company").

ARTICLE II MEMBERS

The Company shall have one or more members (the "Members").

ARTICLE III MAILING ADDRESS

The mailing address for the Company shall be 66 Valencia Avenue, Apartment 303, Coral Gables, Florida 33134.

ARTICLE IV INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE V PURPOSES AND POWERS

**ARTICLE VII
STREET ADDRESS OF PRINCIPAL OFFICE**

The street address of the principal office of the Company shall be located at 66 Valencia Avenue, Apartment 303, Coral Gables, Florida 33134, but it shall have the power and authority to establish branch offices at any other place or places as the Members may designate.

**ARTICLE VIII
MEMBERSHIP RESTRICTIONS**


**ARTICLE IX


