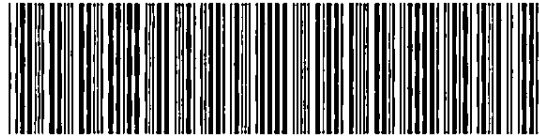

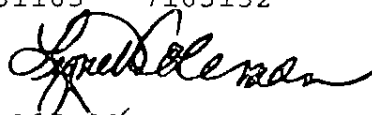

**ARTICLES OF ORGANIZATION
OF
HOFFMANN WATER SPORTS, LLC,
a Florida Limited Liability Company**

The undersigned, being the duly authorized representative of the initial members of a limited liability company to be organized under the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, adopts and submits the following Articles of Organization for such limited liability company:

**ARTICLE I
NAME**

The name of the limited liability company is **HOFFMANN WATER SPORTS, LLC**, a Florida limited liability company (the "Company").

**ARTICLE II
PRINCIPAL PLACE OF BUSINESS**

The mailing address and street address of the principal office of the Company shall be **825 Green Bay Road, Suite 100, Wilmette, IL 60091**.

**ARTICLE III
REGISTERED OFFICE AND REGISTERED AGENT**

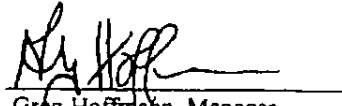
**ARTICLE VIII

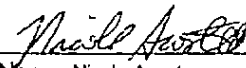
