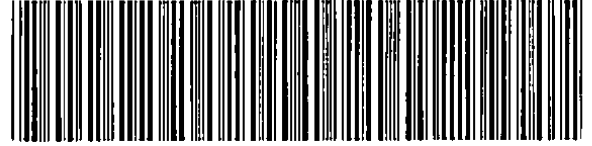

Article VI Management




