**ARTICLES OF AMENDMENT
TO ARTICLES OF ORGANIZATION OF
MSC MIAMI CRUISE TERMINAL LLC**

THE UNDERSIGNED hereby executes and swears to these Articles of Amendment to Articles of Organization of **MSC MIAMI CRUISE TERMINAL LLC**, a Florida limited liability company (the "Company"), pursuant to the Florida Revised Limited Liability Company Act (the "Act"), as amended, Florida Statutes § 605.0202:

1. **Name of Company.** The name of the Company is MSC Miami Cruise Terminal LLC.

2. **Date of Filing of Articles of Organization.** The Company filed Articles of Organization (the "Articles") with the Florida Department of State on July 31, 2019.

3. **Amendment to Articles of Organization.** The undersigned hereby amends Article V of the Articles by deleting the current text of Article V in its entirety and substituting the following in lieu thereof:

"Article V. MANAGEMENT


