ARTICLES OF ORGANIZATION
of
SECOND MOUNTAIN, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes, Chapter 605, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I

NAME

The name of the limited liability company shall be Second Mountain, LLC (the "*Company*"). The mailing and street address of the principal office of the Company in Florida shall be 430 Golden Pond Court, St. Johns, Florida 32259.

ARTICLE II

PURPOSES AND POWERS

ARTICLE VI**MANAGER**
