**ARTICLES OF AMENDMENT
TO
ARTICLES OF ORGANIZATION
OF
STO-IP, L.L.C.**

Pursuant to the provisions of Section 605.0202, Florida Statutes, **STO-IP, L.L.C.**, a Florida limited liability company (the "Company"), adopts the following Articles of Amendment to its Articles of Organization:

- FIRST:** The current name of the Company is STO-IP, L.L.C.
- SECOND:** The company's original Articles of Organization were filed with the Florida Department of State on August 5, 2019 and assigned document number L19000190966.
- THIRD:** Company's Articles of Organization are hereby amended as follows:

1. Article IV of the Company's Articles of Organization is hereby deleted in its entirety and replaced with the following:

"ARTICLE IV – Management and Operating Agreement

The Company is to be managed by its member(s). Any operating agreement entered into by the members of the Company, together with any amendments or restatements thereof, shall be in writing and shall govern all matters relating to the governance of the affairs of the Company, the conduct of its business, and the relation of its members, including without limitation the amendment of these Articles."


2. Article VI of the Company's Articles of Organization is hereby deleted in its entirety.

FOURTH: Except as otherwise set forth herein, the Company's Articles of Organization shall remain in full force and effect.
