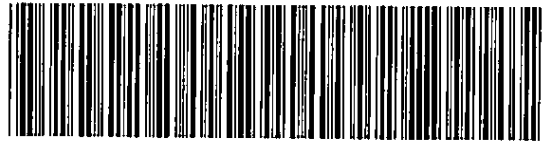



**ARTICLES OF ORGANIZATION  
OF  
PUREST HERBAL CURE, LLC**

The undersigned hereby execute and acknowledge the following Articles of Organization for the purpose of forming a limited liability company in the State of Florida under the Florida Revised Limited Liability Company Act, Chapter 605 of the Florida Statutes.

**1. Name of LLC:**

The name of the limited liability company is **PUREST HERBAL CURE, LLC**.

**2. Address:**

The street address of Purest Herbal Cure, LLC is 11911 Oak Trail Way, Port Richey, Florida 34668.

**3. Registered Agent:**

The registered agent of Purest Herbal Cure, LLC for the purpose of service of process is Dipak M. Parekh at 11911 Oak Trail Way, Port Richey, Florida 34668.

**5. Name and Address of Each Organizer:**

The name and business address of each organizer is:

- a. Dipak M. Parekh at 11911 Oak Trail Way, Port Richey, Florida 34668.
- b. Bakula Parekh at 11911 Oak Trail Way, Port Richey, Florida 34668.

**6. Perpetual Duration:**

The period of duration of Purest Herbal Cure, LLC is perpetual.

**7. Capital Contributions:**

The members of Purest Herbal Cure, LLC shall make an initial cash contribution to the company and additional capital contributions to the company only on the unanimous consent of all the members, or as provided in the regulations.

**8. Management:**

The company shall be managed by its members pursuant to Fla. Stat. 605.0407 in accordance with the regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provision for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. All members shall be subject to the general standards of conduct and care set forth in Fla. Stat. 605.0407. Such duties shall include, without limitation, the duty of loyalty to the company and the duty of care in refraining from

engaging in grossly negligent or reckless conduct, intentional misconduct or a knowing violation of law. In performing his or her duties, any member may rely upon information, reports, advice, opinions and statements, including financial statements, provided by legal counsel, public accountants or other persons the manager reasonably believes are within the provider's expert or professional competence. The company shall indemnify every member, his or her heirs, executors, administrators, and assigns against any expense actually and reasonably incurred by the managers, as well as against any claim, cause of action or judgment, including reasonable attorney's fees, in connection with any judicial or administrative action to which the manager may be a party by reason of having been a manager of this company.

#### **9. Admission of New Members:**

Except as set forth in the regulations, no additional members shall be admitted to Purest Herbal Cure, LLC except with the unanimous written consent of all the members of the company and on such terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless all of the members of the company other than the member proposing to dispose of his or her interest approved of the proposed transfer by written consent.

#### **10. Voting:**

Each percentage of membership interest has one vote on each matter on which the membership interest is entitled to vote. With respect to any matter, other than the admission of new members, the additional contribution of capital or as otherwise set forth in the operating agreement and regulations of the company, the act of the members on that matter shall be the affirmative vote of the holders of a majority of the membership interest entitled to vote on that matter.

#### **11. Continuation of Business:**

The company shall be dissolved in the event of the death, resignation, expulsion, bankruptcy or dissolution of a member or the occurrence of any other event that terminates the continued membership of a member in the company, unless the business of the company is continued by a majority of the remaining members.

#### **12. Purpose:**

Purest Herbal Cure, LLC has been formed for the purpose of importing and selling herbal supplements and for any other lawful purpose.

#### **13. Certificate of Membership:**

A member's interest in Purest Herbal Cure, LLC may be evidenced by a certificate of membership interest, which may be transferred or assigned as provided by law, these articles of organization or the company regulations.

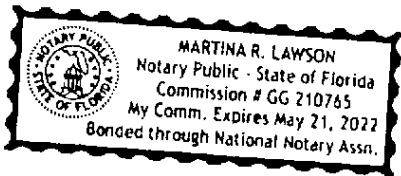
