ARTICLES OF ORGANIZATION OF HARBOR CREEK LLC

SECRETARY OF STATE TALLAHASSEE, FL

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act. F.S. Chapter 605, hereby makes, acknowledges, and files the following Articles of Organization:

ARTICLE I - NAME

The name of this limited liability company is Harbor Creek LLC (the "Company").

ARTICLE II - ADDRESS

The mailing address of the Company, and the street address of the principal office of the Company is 1501 Orange Avenue, Tavares, Florida 32778.
