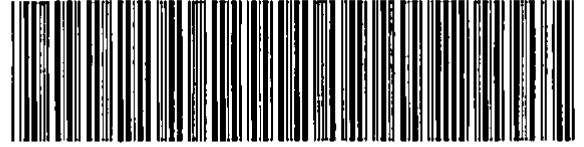

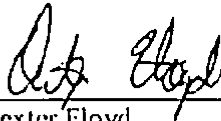
ARTICLE V - Management: The Company shall be managed by a Manager. The initial Manager of the Company shall be Dexter Floyd.
