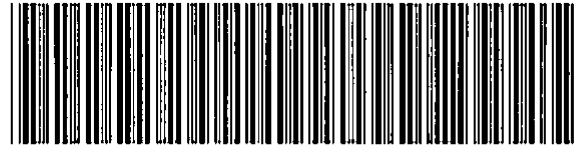

The original articles of Organization are filed as of this 17th day of July 2019, or the date these articles are filed with the Florida Division of Corporations; whichever date is later. Articles of Organization of American Top Team Doral, LLC (hereinafter the "Company") have been duly executed and are being filed in accordance with Florida Statute § 605.0201.

I. ARTICLE I: Name

The name of the Limited Liability Company is American Top Team Doral, LLC.

II. ARTICLE II: Duration

Unless earlier terminated under by Statute or by the Operating Agreement, the period of duration of the Company shall be perpetual.

III. ARTICLE III: Purpose


The purpose of the Company is to (a) engage in the provision of health and fitness related programs and services to the general public and to engage in any and all activities necessary or incidental thereto; (b) The Company shall have all the powers necessary or convenient to carry out the purposes for which it is formed, including the powers granted by the RLLCA.

IV. ARTICLE IV: Address Of Place Of Business

These addresses may be changed from time to time as provided in the Operating Agreement or as updated from time to time in the Company's annual report or amended Articles of Organization.

V. ARTICLE V: Registered Agent

The registered agent in Florida for the Company is Florida Entrepreneur Law, P.A. J. Michelle Suarez, Esq., on behalf of Florida Entrepreneur Law, P.A., hereby duly accept the responsibilities and obligations of serving as Registered Agent for American Top Team Doral LLC. VI. ARTICLE VI: Capital Contributions

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

VII. ARTICLE VII: Members

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement. At the time of the filing of these Amended Articles of Organization, the Company has two Members: Daniela Maza and Juan Maza.

VIII. ARTICLE VIII: Continuity of Business

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.


IX. ARTICLE IX: Management

The Company shall be Manager-Managed by Manager or Managers as selected by majority vote of the Members entitled to vote, which shall initially consist of Daniela Maza, in accordance with the terms and conditions of the Operating Agreement.
