ARTICLES OF AMENDMENT TO ARTICLES OF ORGANIZATION OF

 - The Florida document number of this limited liability company is L19000206274. 3.
- Article V of the Company's Articles of Organization, is deleted in its entirety and the following is substituted therefore: PH 4:

"ARTICLE V MANAGEMENT"
