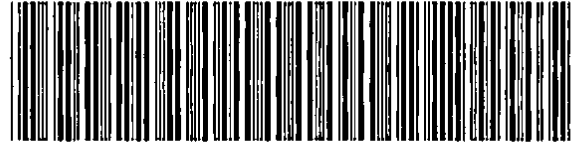

1. **ARTICLES OF ORGANIZATION (PURSUANT TO CHAPTER 605, Fla. Stat.)**

**ARTICLE I
NAME**

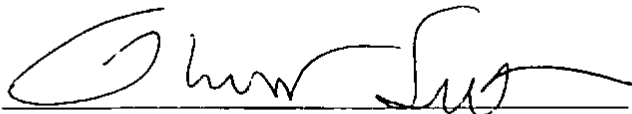
